This is the code that will be used to sign the LOI as a player or as a coach or as a manager.

Steve Yovetich moved to include the verbiage of the tie breaking rules from the USA Hockey Annual in our rules, Section 33 Playoffs and in particular to clarify rule 33.09 (g) with the following "If two or more teams have an equal number of points, their position in the standings shall be determined by the following tiebreaking format. If one tie-breaker establishes a position for one or more teams, each team is placed in the applicable position. Once a team is placed, the remaining tied teams shall start the tiebreaking process over again at step 1..., etc. "

Rosemary Voulelikas also informed the board that the SCAHA Commissioner and Deputy Commissioner terms are up for election next month as well. Bob Driffill asked the board to send the names of those interested to Rosemary so that she may prepare the ballots.
